**SECTION 4 – FIRST AID MEASURES****Inhalation**

Remove to fresh air. If symptoms persist, call a physician.

**Skin contact**

Remove contaminated clothing. Wash affected area immediately with soap and water. Seek medical attention if required.

Flush eye immediately with large amounts of water or normal saline, occasionally lifting eyelids, until no evidence of chemical remains. Seek medical attention if eye irritation persists.

If vomiting occurs keep head lower than hips to help prevent aspiration. Seek medical attention if required.

**Advice to doctor**

If poisoning occurs, apply basic aid and decontamination procedures. Treat symptomatically.

Do not eat, drink or smoke during clean-up operation.
